



## **PUBLIC NOTICE OF AVAILABILITY OF LATE SUBMISSION AND RIGHT TO MAKE FURTHER SUBMISSION**

1. On 9 February 2016 the Christchurch City Council publicly notified a proposal for residential medium density zoning in parts of Hornby, Linwood and Papanui. The period for making submissions on this proposal closed on 22 March 2016. Under the provisions of Clause 5(1)(b) of Schedule 3 Canterbury Earthquake (Christchurch Replacement District Plan) Order 2014, the chair of the Independent Hearings Panel has accepted a late submission from:

Mrs Howley's submission opposes the proposal for Papanui.

4. Any further submission must be limited to a matter in support of, or in opposition to, the submission made by Margaret Howley and must state whether or not you wish to be heard.
5. Any further submission must be served on the Christchurch City Council. A copy must also be served by the further submitter on Margaret Howley within five working days after the further submission is delivered to the Christchurch City Council.
