Reasons for my submission:

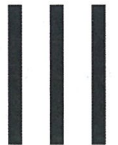
- (1) The University of Canterbury have failed to provide any details of their future proposed uses for the site or any rationale beyond ownership to justify the proposed zoning change.
- (2) The Special Purpose (Tertiary Education) Zone (SPTEZ) provides for, as of right, an extremely wide variety of activities, many of which are not compatible with residential properties where these are in close proximity.
- (3) The potential height, bulk and site coverage of buildings permitted under the SPTEZ are not compatible with the surrounding properties particularly given the restricted size of the site.
- (4) The proposal, if granted, would break up the residential coherence of the area in the vicinity and in particular would both physically, and from a planning perspective, isolate the properties at no's 108, 108A and 110 Waimairi Road.
- (5) The proposal introduces a significant degree of uncertainty as to the future of the properties along Waimairi Road that adjoin the Ilam Fields and hence potentially impacts on the wider area.
